#### Finance

Carol Davis McDonald reported a deposit of \$800 to the NCCWSL fund from three branches. Carol has been away from home but submitted the Finance Report of February 28 following the meeting; a copy is attached. The IBC account has a balance of \$8,745.83 and the NCCWSL fund \$3,383.65.

### **IBC Guideline Changes**

Deb McWard reviewed the 2023 NCCWSL deadlines and scholarship application deadlines. IBC scholarship applications are for CU partner schools. ## **CU Partnership Renewals**

Ellen Irons, Annual Event Chair, gave an update and had provided a report earlier which is attached. Carol Davis McDonald has received 38 registrations; Patty Murray will be sending in two more for guests so the total is now 40. Early payments for raffle tickets received total \$110. Ellen said the March 3 deadline for registration can actually go until March 10. Kay Meyer provided a list of the gift card attractions by branch which is also listed on the attached report. ## Missouri State and Regional Conference

Karen Francis provided initial details about the regional conference. The Missouri State AAUW Conference will be by Zoom to avoid members having to travel and pay for overnight accommodations twice in one year. National AAUW is no longer doing national conferences. Missouri AAUW will host the Central States Conference in St. Louis Thursday through noon Saturday, October 19-21, 2023, at the Drury Plaza Hotel St. Louis at the Arch. States invited to participate are Arkansas, Illinois, Indiana, Iowa, Kansas, Kentucky, Michigan, Minnesota, Missouri, Nebraska, Oklahoma, Tennessee, Texas, and Wisconsin. Programs will begin at 1:00 pm on Thursday and will end at noon on Saturday. Room rates are \$221 per night for two guests. Two additional guests per room may be added at \$10 each. Hotel guests may park in the garage for \$25 per day. Non-guests of the hotel may park at the stadium for \$25 per day. Pat Shores described the hotel's amenities: historic building on the National Register of Historic Places, across the street from the Old Courthouse, one block from the ballpark, pool, workout room, rooftop outdoor area with seating, free breakfast, free Kickback® of hot food, salad and drinks event 5:30 pm to 7 daily. Non-guests may pay to

## **Announcements**

Karen Francis reported that the speakers at the Legislative Retreat were extremely pleased with the participation and support from attendees. Much legislative work was presented at the event.

Pam Meyers watched the Senate Judiciary Committee ERA hearings this morning. The discussion was very heated. Senator Dick Durbin chaired. Those opposed to the ERA believe much more will go into the amendment than what was originally proposed decades ago, including Title IX, women's health issues and gender equality. Opponents also say the timeline for passage has ended and that the process should start all over again. Supporters note that many of the original concerns about the ERA are no longer relevant, such as the draft, as the US no longer has a draft and women are now in combat. Supporters also say the timeline concern is not relevant either because many states have already passed the amendment. Three women became upset and were moved from the hearing.
