#### **OLD BUSINESS**

#### NCCWSL 2023

Deb McWard led a discussion about NCCWSL registration, dates and prices; the conference will be in person this year [5/31/2023 5:00 PM EST to 6/03/2023 12:00 PM EST, University of Maryland, Early Bird Rates (Effective through April 3) are STEM Half-Day Workshop Only (May 31): \$65, Residential Conference Only (June 1-3): \$565, and Commuter Conference Only (June 1-3): \$385]. Deb can send us registrations from last year along with a letter but the letter is 20 years old; should we publicize NCCWSL with flyers and could a "commercial" be created; question about how to get attendees to provide a summary of their experiences to help promote the program such as providing them a detailed form they can fill out and attach pictures rather than writing something from scratch. Pam Meyers asked if there are any recordings from last year. NCCWSL Scholarship Selection Committee needed; so far Ellen Irons, Jan Scott and if anyone else interested, please contact Deb.

#### **CU Connections**

The NCCWSL discussion flowed directly into College University Partnership led by Karen Francis. National has not posted information about which schools have renewed. National is sending out invoices a second time. Karen Francis asked if we should decide as to whether schools should be partners before we offer NCCWSL scholarships and should we have a policy. Students that were sent last year, even if the school has not renewed, should be grandfathered in to allow those students to attend again this year. Marcia Block said AAUW should consider students' merits rather than the schools' partnering. Jan Scott believes student NCCWSL attendance should be what pushes schools to partner. Question from Patty Murray as to whether AAUW's position on abortion rights and Missouri's strict stance is causing some Missouri schools not to partner; SLU has left while Fontbonne and Maryville are rumored to have left for the same reason. Some of our five branches have been paying directly to send students to NCCWSL which is a separate process from the selections that Metro St. Louis IBC makes.

## **Public Policy**

Karen Francis thanked everyone involved in Get Out the Vote. National AAUW approved Missouri AAUW's Public Policy Committee's request to officially write to Missouri Secretary of State Jay Ashcroft about the proposed Missouri's Code of State Regulations, rule number 15 CSR 30-200.015. Libraries must certify in writing that their policies conform to this new rule or lose state funding. Talking points and links packets will be sent to branches; the public has until December 15, 2022 [received by] to offer public comments on this proposal.

Mary Jermak shared that the Legislative Retreat set for early February will be by Zoom.

#### **International Relations Lecture Series**

Kay Meyer reported on progress with the speaker series and a revised flyer is ready, although there has been difficulty with the pdf and email conversion (Mary Jermak offered to assist). The lectures are on the second Tuesdays January through April and held at the Ethical Society. The committee is working on a dual Zoom/in person option, but the lectures will definitely be in person this year. - 1. Karen Francis provided information about the Greatest Needs Campaign, National's 2022 fundraising drive to members. AAUW's most important work is research, programming, and advocacy. Currently, only 4% of the national budget is unrestricted money; 13% of the national budget comes from membership dues. National made a staffing cut in 2018 and are currently at 45 staff members, which is down from 110. The Board is matching Greatest Needs Campaign contributions up to \$80,000; donations are tax deductible.
